Change of Financial Year End from 31 December to 31 March

The Board of Directors ("**Board**") of Skylink Holdings Limited (formerly known as Sincap Group Limited) (the "**Company**") and together with its subsidiaries, the "**Group**") wishes to announce the change of the Company's financial year end from 31 December to 31 March. Following the change of financial year end, the next set of audited financial statements of the Company for the financial year ending 31 March 2026 will cover a period of 15 months from 1 January 2025 to 31 March 2026 ("**FY25/26**").

The change of the financial year end serves to align with the financial year end of Skylink APAC Pte. Ltd. and to facilitate better management of resources for smooth flow of business operations and financial reporting of the Group following the completion of the acquisition of Skylink APAC Pte. Ltd. on 15 September 2025 (the "**Reverse Takeover**").

In accordance with the Singapore Financial Reporting Standard (International) 3 – Business Combinations, the Group's consolidated financial statements following the completion of the Reverse Takeover will be prepared and issued under the name of the legal parent, being the Company. The financial results for FY25/26 and its comparatives for the Group's consolidated financial statements will thus be presented as a continuation of the financial statements of the legal subsidiary, Skylink APAC Pte. Ltd., which will cover a period of 15 months from 1 January 2025 to 31 March 2026 with 1 January 2024 to 31 December 2024 as comparatives.

In accordance with Rule 705 of the Singapore Exchange Securities Trading Limited ("**SGX-ST**") Listing Manual Section B: Rules of Catalyst ("**Catalist Rules**"), the Company will be releasing the announcements of its financial results as set out in the table below:
